University of Lagos, Nigeria Does Africa perceive itself as a unified entity, embodying a common identity and purpose, or does it see itself as a collection of Weberian states defined by distinct political entities and bureaucracies? This question stems from the long history of failed or ineffective efforts to engender continental self-identity and consciousness. Given their colonial foundations, African states carry on colonially imposed identities that continue to make it difficult for a continent to see itself differently.

In Collaboration Mith

Early post-colonial leaders such as Kwame Nkrumah noted the

Danger of segregated identities in Africa and advocated for the establishment of the United States of Africa. The aim was to foster a sense of oneness on the continent such that Africans could see one another as people rather than as citizens of different colonially created states. Further efforts, such as the African Union (AU) and regional economic communities, reflect the desire for collective action and solidarity. However, challengessuch as internal conflicts, weak governance, and competing national interests often hinder progress towards unity. The establishment of the African Continent Free Trade Area (AfCFTA) is one of the latest efforts to engender African unity and development based on correct self-identity. However, this does not yield optimal

results, as intra-African economic engagement remains low. The Weberian identity of African states is at the heart of issues and challenges such as xenophobia, ethnic violence and tensions, religious intolerance, cross-border violence and crime, irredentism, and undue external manipulation, among others. The implications of Africa's unity, regional integration, cultural exchange and collaboration, and global influence are dire. As Africa navigates the complexities of the 21st century, fostering a sense of shared identity and purpose is essential for addressing common challenges and unlocking the continent's full potential. Given this, academics, students, researchers, CSO and NGO practitioners, government officials, policymakers, and other stakeholders are invited to explore the following and other relevant sub-themes.
